My son has been in both the local and international education systems and I have, unfortunately, witnessed how the local system turned a happy, gifted child into a suicidal, socially withdrawn kid. Therefore I understand and appreciate the unique position of ESF in Hong Kong. Moreover, I have been on the ESF Board for three years. It had been a challenging three years but we have finally settled the subvention issue with the government, minimised the increase of school fee and established a five-year strategic plan.

However, we are not without future challenges. The Island School redevelopment and subvention for special needs education are still under debate with the current administration. I hope with my involvement with the Legislative Council and the Education Bureau, I could:

- ensure that our government understands the importance of ESF in the Hong Kong education ecosystem, thus gaining more support from the government.
- provide the much needed continuity to help ESF evolve into a self-sustaining entity and face the increasing competitions from other international schools.
- safeguard the quality of teaching and prevent political interference. Teachers should be free of the burden of bureaucracy and should use their time fully to educate our children. They should be allowed to innovate without pressures.
- increase the transparency of ESF's governance and the accountability of its senior management. It is particularly important in this turbulent time.

As a parent, I shall be relentlessly monitoring the quality of education provided by ESF and ensure that every penny spent would be to the benefit of our children. I would therefore hope to be given a chance to serve you and the ESF community again.

Unique understanding of ESF

Having attended ESF schools myself (Beacon Hill, Shatin Junior & Shatin College) and now as current parent, I have a unique perspective to bring to the table. With 22 schools under the Foundation's remit, the need to share best practices, realise efficiencies and identify collective areas for improvement across the different schools is increasingly important.

Election of parent members to the ESF Board of Governors 2017 Candidate's Personal Statement

Five years ago, the word 'affordable' was quietly and permanently dropped by ESF, with the result that at the current rate of annual increases, an ESF education will cost HK\$2-3 million per child.

With the subvention also dropped (despite its apparent enshrinement in the Basic Law), this conveniently removed the Government from providing a control mechanism over ESF.

I am concerned about this. Like many of you, I work for an employer where I receive no help with school fees and on a local terms package.

If elected, this is what I would focus on:

- Reintroduce the concept of 'affordability', (which was eliminated as it was deemed 'relative and subjective', but appears to have opened the flood gates for fee increases).
- Review whether ESF could join the Hong Kong Government's Direct Subsidy Scheme and obtain a unit rate per child per year at the same rate as other DSS schools, without compromising the curriculum.
- Require the ESF to publish the names of its top 50 non-teaching staff, their remuneration, their job titles, place of work, and a brief description of what they actually do on a day-to-day basis.
- Require a root and branch review of the management role both centrally and within schools, establish where roles overlap and savings may be made.
- Put an end to vanity building projects which pander more to architectural aesthetics rather than being practical school buildings that are environmentally sustainable and inexpensive to maintain.
- By sending our children to ESF schools, we have removed the burden of education from the Government. However, the Government currently does not extend any tax concessions in relation to our children's school fees. Another potential approach would be to explore whether the foundation can obtain charitable status permitting a legitimate income-tax deduction by means of charitable donation for taxpayers. I will ask the ESF to explore whether this can be accomplished.

If not kept in check, the compound effect of 6% increases to fees will place some families and single income families at risk of needing to remove children mid-way through their journeys and/or leave Hong Kong. It is already happening. People who lose their jobs cannot afford an ESF education.

Please vote for me and I will fight to ensure transparency.
